Market Rules:

1. Please arrive in enough time to set up and be ready to sell by market time, 4:00.
2. Please plan to stay until the end – great networking opportunity for future sales.
3. Vendors are responsible for their own tables, chairs and backdrops – please plan on a clean, well-presented space.
4. Space must be kept clean. You must leave your space clean at the close of each market. You may be assessed a cleanup fee if noncompliant.
5. Be prepared with change for your customers.
6. Our goal is a clean, attractive Market. Awnings or umbrellas are highly recommended for shade and weather protection. Be prepared for Wyoming weather – plan to anchor your tent in case of windy conditions.
7. Produce must be identified as Self-grown (your own farm or garden); Organic (certification required) or Supplemental (produce from neighbor or purchased from other farmers – may not be purchased from a store, produce house, etc.).
8. A sign with you product name and farm name is encouraged.
9. Please review and understand the Wyoming Farmers Market Guidelines for 2008

These rules are subject to change, with proper written notice to each vendor, if there are other conditions we have not anticipated.

Fees:

Fee for the August-September season is \$30.00 – Payable on or before August 1, 2008

For 2008, there will be no fees for July or October Markets

Hold Harmless Agreement:

In consideration of acceptance of this application, the undersigned vendor (if group, this agreement applies to every member of the group):
